

# PRIVACY POLICY

## 1. Introduction

The privacy of our website visitors is very important to us, so we are committed to protecting it.

1.1 This privacy policy is valid for the purposes of Article 13 of Regulation (EU) No. 2016/679 on the protection of natural persons with regard to the processing of personal data and the free circulation of such data, for those who interact with our website [www.checcchino-dal-1887.com](http://www.checcchino-dal-1887.com).

1.2 The information is provided only for the website [www.checcchino-dal-1887.com](http://www.checcchino-dal-1887.com) and not for other websites that may be consulted by the user via links contained therein.

1.3 Through this declaration we want to clearly communicate the reason for the data collection and the way in which we process it. We collect and use only legitimate data that will be communicated to us and only after the explicit consent of the person providing it. If the user is under fourteen years of age, pursuant to art. 8, c.1 Regulation (EU) 2016/679 and Art. 2 Quinquies of Legislative Decree 196/2003, as amended by Legislative Decree 181/18, must legitimize his/her consent through the authorization of his/her parents or legal guardians.

1.4 We adopt all security measures to protect the data provided to us and we also ask this of all those who collaborate with us in order to provide the services requested through the data and consent to their processing.

## 3. Legal basis for processing

## 4. Browsing data

4.1 The computer systems and software procedures used to operate this website acquire, during their normal operation, some personal data whose transmission is implicit in the use of internet communication protocols. ## **5. Collection of personal data**

## **6. Use of personal data**

The personal information you submit to us via our website will be used for the purposes set out in this policy or on the relevant pages of the website. We may use this information for the following purposes:

6.4 To send you email notifications that you have specifically requested (e.g. booking confirmations);

6.5 To provide third parties with statistical data about our users (such third parties will not be able to identify individual users from this information);

## **7. Disclosure of personal data**

We may disclose personal information:

- 7.3 in order to establish, exercise or defend our legal rights (including providing information to third parties for the purposes of fraud prevention);
- 7.4 Except as provided in this policy, we will not provide any information or personal data to third parties.

## **8. Retention of personal data**

**8.1** This section sets out our data retention policies and procedure, which are designed to help ensure that we comply with our legal obligations regarding the retention and deletion of personal data and information.

**8.2** We will retain personal information for no longer than is necessary for the purposes for which it was provided to us and subject to your explicit consent prior to processing. We will delete the data at the end of the requested service unless you explicitly ask us to retain it for any other communications with us.

**8.3** Notwithstanding the other provisions of this section, we will retain documents (including electronic documents) containing personal data:

8.3.1 To the extent that we are required by law;

8.3.1 If we believe that such documents may be relevant to any ongoing or future legal proceedings;

8.3.2 To establish, exercise or defend our legal rights (including providing information to third parties for fraud prevention purposes).

## **9. Security of personal data**

**9.1** We will take reasonable technical and organizational precautions to prevent any loss, misuse or alteration of the information in our possession.

**9.2** We will store all personal information provided to us on our secure servers (adequately protected by passwords and firewalls).

**9.3** It is known, however, that the transmission of information online is by its nature insecure and that we cannot guarantee the security of data sent via the Internet.

## **10. Changes**

We may occasionally update this policy by posting a new version on our website. We therefore invite our users to periodically check this page to ensure they have understood any changes made to the policy. ## **11. User rights**

The user is guaranteed respect for his rights in the field of personal data protection, in line with what is taken up and stated by the GDPR in relation to the processing of his personal data, the user has the right to ask the owner:

**11.1 Access**, the user can ask for confirmation as to whether or not data processing concerning him is in progress

11.2 **Rectification**, the user can ask to rectify or integrate the data he has provided

11.3 **Cancellation**, he can request cancellation if they are no longer necessary for the purpose for which they were provided

11.4 **Limitation**, he can ask that his data be processed only for the purposes of conservation, with the exclusion of other processing.

11.5 **Opposition**, he can object at any time to the processing of his data, unless there are legitimate reasons of the Owner to proceed with the processing that prevail over his, for example in court.

11.6 **Portability**, you can ask to receive your data in a structured format of common use and readable.

11.7 **Revocation** You can revoke your consent to the use of cookies at any time.

However, the revocation of consent does not affect the lawfulness of the processing based on the consent carried out before the revocation.
